The Yadkin Valley Wine Festival is an all-inclusive wine, food, music and craft festival.

We are offering exclusive rental space to enjoy the festival to the fullest.

To be eligible you must fill out the application and mail it back in along with your payment. The festival committee will review all applications and assigned spaces.

Applicants must be a legal adult and over the age of 21. Please check additional rental items that will be provided upon written request and for your convenience. A Damage Deposit of \$50 is required. The deposit will be refunded should the area be clear of trash and debris after the event.

All spaces are rented on a “first-come/first-serve” basis. The Yadkin Valley Chamber of Commerce will not reserve spaces without full payment. Refunds will not be provided prior to 30 days of the event. All applications are subject to approval by the Yadkin Valley Wine Festival Committee.

I/we understand this application becomes a binding contract when accepted and signed by Yadkin Valley Chamber of Commerce and that once accepted, fees are non-refundable. I/we agree to abide by any rules and regulations published here as well as any additions.

- All items must be carried in, no vehicles are allowed on festival grounds.
- Any and all trash will be disposed of in trash receptacle provided.
- No fire, grills or other flame/cooking equipment is allowed.
- Any and all decorations must be removed after the event.
- Coolers and pets are not allowed. (Service dogs are allowed but must have paperwork).
- Any damage to personal items such as tents, chairs, decorations or other items due to weather or other unforeseen causes are not the responsibility of the Yadkin Valley Chamber of Commerce or the Town of Elkin.
- All other event rules and regulations set forth by the Yadkin Valley Chamber of Commerce or the Town of Elkin are in effect and enforceable.
