Applications received before **04/01/2025** will receive priority consideration for location and special requests. Applications received after that date are not guaranteed such consideration, depending on space and planning limitations, and will incur a non-refundable \$50 late fee.

A certificate of general liability of at least \$1 million naming the Yadkin Valley Chamber of Commerce and the Town of Elkin as additional insured for May 15-17, 2026 must be provided to the Chamber upon acceptance of this application.

NOTE:

- Wineries/vineyards with a physical presence outside the Yadkin Valley or Swan Creek AVAs may only pour or sell wines that have a TTB label indicating 'Yadkin Valley' or 'Swan Creek' appellations.
- Paid attendees will have their photo ID checked and a tasting wristband affixed at check-in. **Wristbands required for tasting or purchasing.** Friday PM or Saturday AM is available for set-up. Wineries must remain on site until 5pm Saturday unless bad weather pending.
- Wineries/vineyards may not sell "wine slushies. Wine tasting may begin no earlier than 10:30 a.m.
- Wineries/vineyards may only sell or pour from containers with TTB approved 'Sangria' labels.

I/we understand this application becomes a binding contract when accepted and signed by Yadkin Valley Chamber of Commerce. I/we agree to abide by any rules and regulations published here as well as any additions. Wineries will receive 2 festival glasses, tasting wristbands for staff serving at the event and lunch delivered to your tent. Wineries will need to provide their own glasses for the extra staff tasting wrist bands.
